

麻雀房使用守則

- 1. 使用人士必須為持有已登記八達通之住戶或由其陪同之訪客。
- 2. 使用人士須出示已登記八達通及於接待處辦理租用手續後,才能進入及使用麻雀房設施。
- 3. 只供十八歲或以上人士使用。
- 4. 麻雀房使用人數上限人數為5人。
- 5. 不可在麻雀房內進行任何涉及金錢交易活動。
- 6. 使用人士請將使用後的器材放回原位及嚴禁隨意移動麻雀房<mark>之器材傢</mark>俬,如有損毀,須按照市價賠償一切損失。
- 7. 麻雀房範圍內嚴禁吸煙、飲食或拋棄垃圾。
- 8. 倘若任何人士經常違反上述規則或故意騷擾或危害其他使用<mark>人安全,</mark>會所有權拒絕該等人士進入會所範圍內。
- 9. 會所有權隨時關閉麻雀房,以便進行清潔、保養或維修工程,而無須事前通知。
- 10. 除獲會所批准外,麻雀房內不可作其他活動用途。
- 11. 使用人士須自行負責本身之財物,管理公司對私人物品之損毀或被竊概不負責。
- 12. 會所為住客安排特別課程或項目期間,麻雀房將不開放予其他人士使用。
- 13. 確定租用場地後,不設退款或更改場地安排。
- 14. 會所保留隨時更改以上麻雀房使用規則之權利而毋須另行通知。
- 15. 麻雀房只供業主、租客或授權人士使用。業主及管理公司不會對麻雀房使用人士的安全負上任何責任,敬請留意。

Mahjong Room Regulations

- 1. All users must be a holder of registered Octopus Card of AquaMarine or a guest whom are accompanied by residents with registered Octopus Card.
- 2. All users must present their registered Octopus Card and register before they are permitted to use the Mahjong Room.
- 3. For users aged eighteen (18) or above only.
- 4. The maximum user capacity of Mahjong Room is 5 persons.
- 5. Any kinds of activities involving money transaction are prohibited in the Mahjong Room.
- 6. The equipment should be returned to the original position after use and relocation of the equipment inside the Mahjong Room is strictly prohibited. User will be held liable and required to pay full compensation at market rate for any damages to the equipment / furniture.
- 7. Smoking, drinking, eating and littering are strictly prohibited in the Mahjong Room.
- 8. Club Aqua shall reserve the right to refuse admittance for any person who habitually disregards any of the aforesaid requirements and / or causes nuisance and / or danger to other users.
- 9. Club Aqua shall reserve the right to suspend the Mahjong Room at any time and / or for any period of time for cleaning purpose and / or maintenance repairs without prior notice.
- 10. No other activity is allowed in the Mahjong Room unless prior approval is obtained from Club Aqua.
- 11. The management shall not be held liable for any loss of and / or damage to any personal properties and / or belongings. All users of the Mahjong Room are at their sole responsibilities.
- 12. For training session and / or demonstration specially arranged by Club Aqua, the Mahjong Room will be reserved for such purpose.
- 13. No refund or change of time is allowed after confirmed the reservation.
- 14. Club Aqua shall reserve the right to amend the above guidelines without prior notice.
- 15. This Mahjong Room operates for the sole benefit of owners, tenants, users and visitors. The owner and management will not take any responsibility for the usage of all equipment and the safety of all users in this Mahjong Room nor will take any responsibility for advice given by any of the instructors.
