

蒸氣及桑拿浴室使用守則

- 1. 使用人士必須為持有碧海藍天智能咭之住戶或由持有智能咭住戶陪同之訪客。
- 2. 使用人士須出示已登記的智能咭及於接待處辦理登記手續後,才能使用蒸氣及桑拿浴室設施。
- 3. 只供十六歲或以上人士使用。
- 4. 有身孕之婦女、患有心臟病、血液循環不良、曾服用藥物、酒<mark>精、皮膚</mark>病或傳染病人士請勿使用蒸氣及桑拿浴室。
- 5. 建議使用時間為三至十分鐘。
- 6. 蒸氣及桑拿浴室每項設施使用人數上限為 12 人。
- 7. 使用人士必須用清潔毛巾包裹身體或穿著泳裝。
- 8. 不可使用任何護膚、焗油或染髮用品。
- 9. 請勿攜帶報章、雜誌進入蒸氣及桑拿浴室。
- 10. 蒸氣及桑拿浴室範圍內嚴禁吸煙、飲食或拋棄垃圾。
- 11. 倘若任何人士經常違反上述規則或故意騷擾或危害其他使用人安全,會所有權拒絕該等人士進入會所範圍內。
- 12. 會所有權隨時關閉蒸氣及桑拿浴室,以便進行清潔、保養或維修工程,而無須事前通知。
- 13. 使用人士須自行負責本身之財物,管理公司對私人物品之損毁或被竊概不負責。
- 14. 會所保留隨時更改以上蒸氣及桑拿浴室使用規則之權利而毋須另行通知。
- 15. 蒸氣及桑拿浴室只供業主、租客或授權人士使用。業主及管理公司不會對蒸氣及桑拿浴室使用人士的安全負上任何責任,敬請留意。

Steam / Sauna Regulations

- 1. All users must be a holder of registered Smart Cards of AquaMarine or a guest accompanied by a resident who can produce his or her Smart card.
- 2. All users must present their registered Smart Cards and register before they are permitted to use the Steam / Sauna.
- 3. For users aged sixteen (16) or above only.
- 4. Persons with pregnant, heart disease, poor blood circulation, skin disease, infectious and contagious diseases or those after drinking, taking drug should not use the Steam / Sauna facilities.
- 5. 3 to 10 minutes usage time is recommended.
- 6. Maximum of 12 persons are allowed to stay in the Steam / Sauna at any one time.
- 7. All users must be worn swimming suit or wrapped with clean towel.
- 8. Cosmetic, hair treatment or hair dye products are prohibited in the Steam / Sauna.
- 9. Please do not bring newspaper or magazine entering the Steam / Sauna.
- 10. Smoking, drinking, eating and littering are strictly prohibited in the Steam / Sauna.
- 11. Club Aqua shall reserve the right to refuse admittance for any person who habitually disregards any of the aforesaid requirements and / or causes nuisance and / or danger to other users.
- 12. Club Aqua shall reserve the right to suspend the Steam / Sauna at any time and / or for any period of time for cleaning purpose and / or maintenance repairs without prior notice.
- 13. The management shall not be held liable for any loss of and / or damage to any personal properties and / or belongings. All users of the Steam / Sauna are at their sole responsibilities.
- 14. Club Aqua shall reserve the right to amend the above guidelines without prior notice.
- 15. This Steam / Sauna operates for the sole benefit of owners, tenants, users and visitors. The owner and management will not take any responsibility for the usage of all equipment and the safety of all users in this Steam / Sauna nor will take any responsibility for advice given by any of the instructors.
