

羽毛球場使用守則

- 1. 使用人士必須為持有已登記八達通之住戶或由其陪同之訪客。
- 2. 使用人士須出示已登記八達通及於接待處辦理租用手續後,才能進入及使用羽毛球場設施。
- 3. 十二歲以下人士,必須由成人陪同下方可使用羽毛球場。
- 4. 羽毛球場使用人數上限為10人。
- 5. 進入羽毛球場之人士,須穿著不脫色鞋底之運動鞋。
- 6. 使用人士必須視乎本身之身體健康狀況,凡患有高血壓、心臟病、服藥或酒後之人士,避免進行烈劇 運動。如有任何疑問,請先諮詢醫生意見。
- 7. 使用人士嚴禁隨意移動羽毛球場內之器材傢俬,如有損毀,須按照市價賠償一切損失。
- 8. 使用人士不得攜帶飲品或食物進入羽毛球場。
- 9. 羽毛球場範圍內嚴禁吸煙、飲食或拋棄垃圾。
- 10. 除獲會所批准之教練外,其他人士不可在羽毛球場內進行教練工作。
- 11. 除獲會所批准外,羽毛球場內不可作其他活動用途。
- 12. 倘若任何人士經常違反上述規則或故意騷擾或危害其他使用人安全,會所有權拒絕該等人士進入會所 範圍內。
- 13. 會所有權隨時關閉羽毛球場,以便進行清潔、保養或維修工程,而無須事前通知。
- 14. 使用人士須自行負責本身之財物,管理公司對私人物品之損毁或被竊概不負責。
- 15. 會所為住客安排特別課程或項目期間,羽毛球場將不開放予其他人士使用。
- 16. 確定租用場地後,不設退款或更改場地安排。
- 17. 會所保留隨時更改以上羽毛球場使用規則之權利而毋須另行通知。
- 18. 羽毛球場只供業主、租客或授權人士使用。業主及管理公司不會對羽毛球場使用人士的安全負上任何 責任,敬請留意。

Badminton Court Regulations

- 1. All users must be a holder of registered Octopus Card of AquaMarine or a guest whom are accompanied by residents with registered Octopus Card.
- 2. All users must present their registered Octopus Cards and register before they are permitted to use the Badminton Court.
- 3. All users under the age of twelve (12) should be accompanied by an adult who shall remain in attendance at all times and be fully responsible for any child in whose care.
- 4. The maximum user capacity of Badminton Court is 10 persons.
- 5. Non-staining rubber sports shoes must be worn when entering the Badminton Court
- 6. All users are advised to check their own physical, users who are suffering from high blood pressure, heart diseases or those after drinking, taking drug are advised not to do excited exercise. For any queries, users are advised to consult their doctors for medical advice before using the facility.
- 7. Relocation of the equipment inside the Badminton Court is strictly prohibited. User will be held liable and required to pay full compensation at market rate for any damages to the equipment / furniture.
- 8. All users should not bring any drinks or foods enter the Badminton Court.
- 9. Smoking, drinking, eating and littering are strictly prohibited in the Badminton Court.
- 10. No coaching is permitted in the Badminton Court unless prior approval is obtained from Club Aqua.
- 11. No other activity is allowed in the Badminton Court unless prior approval is obtained from Club Aqua.
- 12. Club Aqua shall reserve the right to refuse admittance for any person who habitually disregards any of the aforesaid requirements and / or causes nuisance and / or danger to other users.
- 13. Club Aqua shall reserve the right to suspend the Badminton Court at any time and / or for any period of time for cleaning purpose and / or maintenance repairs without prior notice.
- 14. The management shall not be held liable for any loss of and / or damage to any personal properties and / or belongings. All users of the Badminton Court are at their sole responsibilities.
- 15. For training session and / or demonstration specially arranged by Club Aqua, the Badminton Court will be reserved for such purpose.
- 16. No refund or change of time is allowed after confirmed the reservation.
- 17. Club Aqua shall reserve the right to amend the above guidelines without prior notice.
- 18. This Badminton Court operates for the sole benefit of owners, tenants, users and visitors. The owner and management will not take any responsibility for the usage of all equipment and the safety of all users in this Badminton Court nor will take any responsibility for advice given by any of the instructors.
