

荷里活電影院 使用守則

- 1. 使用人士必須為持有已登記八達通之住戶或由其陪同之訪客。
- 2. 使用人士須出示已登記八達通及於接待處辦理租用手續後,才能進入及使用荷里活動電影院。
- 3. 十二歲以下人士,必須由成人陪同下方可使用荷里活電影院。
- 4. 荷里活電影院最多容納人數上限為 24 人。
- 5. 不可在荷里活電影院內進行任何商業及金錢交易活動。
- 6. 使用人士請將使用後的器材放回原位及嚴禁隨意移動荷里活電影院內之器材傢俬,如有損毀,須按照 市價賠償一切損失。
- 7. 使用人士不得攜帶飲品或食物進入荷里活電影院。
- 8. 荷里活電影院內嚴禁吸煙、進食或拋棄垃圾。
- 9. 倘若任何人士經常違反上述規則或故意騷擾或危害其他使用人安全<mark>,會所有權</mark>拒絕該等人士進入會所 範圍內。
- 10. 除獲會所批准外,荷里活電影院內不可作其他活動用途。
- 11. 會所有權隨時關閉荷里活電影院,以便進行清潔、保養或維修工程,而無須事前通知。
- 12. 使用人士須自行負責本身之財物,管理公司對私人物品之損毁或被竊概不負責。
- 13. 會所為住客安排特別課程或項目期間,荷里活電影院將不開放予其他人士使用。
- 14. 確定租用場地後,不設退款或更改場地安排。
- 15. 會所保留隨時更改以上荷里活電影院使用規則之權利而毋須另行通知。
- 16. 荷里活電影院只供業主、租客或授權人士使用。業主及管理公司不<mark>會對荷里</mark>活電影院使用人士的安全 負上任何責任,敬請留意。

Hollywood Theatre Regulations

- 1. All users must be a holder of registered Octopus Card of AquaMarine or a guest whom are accompanied by residents with registered Octopus Card.
- 2. All users must present their registered Octopus Card and register before they are permitted to use the Hollywood Theatre.
- 3. All users under the age of twelve (12) should be accompanied by an adult who shall remain in attendance at all times and be fully responsible for any child in whose care.
- 4. The maximum user capacity of Hollywood Theatre is 24 persons.
- 5. Any kinds of commercial activities or activities involving money transaction are prohibited in the Hollywood Theatre.
- 6. The equipment should be returned to the original position after use and relocation of the equipment inside the Hollywood Theatre is strictly prohibited. User will be held liable and required to pay full compensation at market rate for any damages to the equipment / furniture.
- 7. All users should not bring any drinks or foods enter the Hollywood Theatre.
- 8. Smoking, eating and littering are strictly prohibited in the Hollywood Theatre.
- 9. Club Aqua shall reserve the right to refuse admittance for any person who habitually disregards any of the aforesaid requirements and / or causes nuisance and / or danger to other users.
- 10. No other activity is allowed in the Hollywood Theatre unless prior approval is obtained from Club Aqua.
- 11. Club Aqua shall reserve the right to suspend the Hollywood Theatre at any time and / or for any period of time for cleaning purpose and / or maintenance repairs without prior notice.
- 12. The management shall not be held liable for any loss of and / or damage to any personal properties and / or belongings. All users of the Hollywood Theatre are at their sole responsibilities.
- 13. For training session and / or demonstration specially arranged by Club Aqua, the Hollywood Theatre will be reserved for such purpose.
- 14. No refund or change of time is allowed after confirmed the reservation.
- 15. Club Aqua shall reserve the right to amend the above guidelines without prior notice.
- 16. This Hollywood Theatre operates for the sole benefit of owners, tenants, users and visitors. The owner and management will not take any responsibility for the usage of all equipment and the safety of all users in this Hollywood Theatre nor will take any responsibility for advice given by any of the instructors.
