

## 桌球室使用守則

- 1. 使用人士必須為持有碧海藍天智能咭之住戶或由持有智能咭住戶陪同之訪客。
- 2. 使用人士須出示已登記的智能咭及於接待處辦理租用手續後,才能進入及使用桌球室設施。
- 3. 十二歲以下人士,必須由成人陪同下方可使用桌球室。
- 4. 桌球室使用上限人數為8人。
- 5. 不可在桌球室內進行任何涉及金錢交易活動。
- 6. 使用人士請將使用後的器材放回原位及嚴禁隨意移動桌球室內之<mark>器材傢俬</mark>,如有損毀,須按照市價 賠償一切損失。
- 7. 使用人士不得攜帶飲品或食物進入桌球室。
- 8. 桌球室範圍內嚴禁吸煙、飲食或拋棄垃圾。
- 9. 除獲會所批准之教練外,其他人士不可在桌球室內進行教授工作。
- 10. 倘若任何人士經常違反上述規則或故意騷擾或危害其他使用人安全,會所有權拒絕該等人士進入會 所範圍內。
- 11. 除獲會所批准外,桌球室內不可作其他活動用途。
- 12. 會所有權隨時關閉桌球室,以便進行清潔、保養或維修工程,而無須事前通知。
- 13. 使用人士須自行負責本身之財物,管理公司對私人物品之損毁或被竊概不負責。
- 14. 會所為住客安排特別課程或項目期間,桌球室將不開放予其他人士使用。
- 15. 確定租用場地後,不設退款或更改場地安排。
- 16. 會所保留隨時更改以上桌球室使用規則之權利而毋須另行通知。
- 17. 桌球室只供業主、租客或授權人士使用。業主及管理公司不會對桌球室使用人士的安全負上任何責任,敬請留意。

## **Billiard Room Regulations**

- 1. All users must be a holder of registered Smart Cards of AquaMarine or a guest accompanied by a resident who can produce his or her Smart Card.
- 2. All users must present their registered Smart cards and register before they are permitted to use the Billiard Room.
- 3. All users under the age of twelve (12) should be accompanied by an adult who shall remain in attendance at all times and be fully responsible for any child in whose care.
- 4. Maximum of 8 persons are allowed to stay in the Billiard Room at any one time.
- 5. Any kinds of commercial activities or activities involving money transaction are prohibited in the Billiard Room.
- 6. The equipment should be returned to the original position after use and relocation of the equipment inside the Billiard Room is strictly prohibited. User will be held liable and required to pay full compensation at market rate for any damages to the equipment / furniture.
- 7. All users should not bring any drinks or foods enter the Billiard Room.
- 8. Smoking, drinking, eating and littering are strictly prohibited in the Billiard Room.
- 9. No coaching is permitted in the Billiard Room unless prior approval is obtained from Aqua Club.
- 10. Club Aqua shall reserve the right to refuse admittance for any person who habitually disregards any of the aforesaid requirements and / or causes nuisance and / or danger to other users.
- 11. No other activity is allowed in the Billiard Room unless prior approval is obtained from Club Aqua.
- 12. Club Aqua shall reserve the right to suspend the Billiard Room at any time and / or for any period of time for cleaning purpose and / or maintenance repairs without prior notice.
- 13. The management shall not be held liable for any loss of and / or damage to any personal properties and / or belongings. All users of the Billiard Room are at their sole responsibilities.
- 14. For training session and / or demonstration specially arranged by Club Aqua, the Billiard Room will be reserved for such purpose.
- 15. No refund or change of time is allowed after confirmed the reservation.
- 16. Club Aqua shall reserve the right to amend the above guidelines without prior notice.
- 17. This Billiard Room operates for the sole benefit of owners, tenants, users and visitors. The owner and

management will not take any responsibility for the usage of all equipment and the safety of all users in this Billiard Room nor will take any responsibility for advice given by any of the instructors.
