

獨眼船長王國使用守則

- 1. 使用人士必須為持有碧海藍天智能咭之住戶或由持有智能咭住戶陪同之訪客。
- 2. 獨眼船長王國主要供四至九歲及身高不超過 140 厘米的兒童使用。
- 3. 小童必須由成人陪同下方可使用獨眼船長王國。
- 4. 使用者必須把鞋子脫下,並穿上襪子方進入獨眼船長王國。
- 使用人士嚴禁隨意移動獨眼船長王國內之器材傢俬,如有損毀,須按照市價賠償一切損失。
- 使用者的家長或監護人首先須檢驗該等遊樂設備,以確保該些設備的操作情況正常適合使用。
- 7. 請勿將兒童遊戲室的玩具帶離遊戲室。
- 8. 使用者請將玩具放回原有地方。
- 9. 在獨眼船長王國內,請勿追逐。
- 10. 會所職員有權因上述地方過於擠擁而調節入場人數。
- 11. 使用人士不得攜帶食物進入獨眼船長王國。
- 12. 獨眼船長王國室範圍內嚴禁吸煙、飲食或拋棄垃圾。
- 13. 除獲會所批准之教練外,其他人士不可在獨眼船長王國內進行教練工作。
- 14. 倘若任何人士經常違反上述規則或故意騷擾或危害其他使用人安全<mark>,會所有權</mark>拒絕該等人士進入會所 範圍內。
- 15. 會所有權隨時關閉獨眼船長王國,以便進行清潔、保養或維修工程,而無須事前通知。
- 16. 使用人士須自行負責本身之財物,管理公司對私人物品之損毁或被竊概不負責。
- 17. 會所為住客安排特別課程或項目期間,獨眼船長王國將不開放予其他人士使用。
- 18. 會所保留隨時更改以上獨眼船長王國使用規則之權利而毋須另行通知。
- 19. 獨眼船長王國只供業主、租客或授權人士使用。業主及管理公司不<mark>會對獨眼</mark>船長王國使用人士的安全 負上任何責任,敬請留意。

Indoor Children Play Area Regulations

- 1. All users must be a holder of registered Smart Cards of AquaMarine or a guest accompanied by a resident who can produce his or her Smart Card.
- 2. The Indoor Children Play Area is mainly designed for the use by children aged from four (4) to nine (9) whose heights are not exceeding 140cm.
- 3. Children should be accompanied by an adult who shall remain in attendance at all times and be fully responsible for any child in whose care.
- 4. All users should take off the shoes and wear the socks before entry the Indoor Children Play Area.
- 5. Relocation of the equipment inside the Indoor Children Play Area is strictly prohibited. User will be held liable and required to pay full compensation at market rate for any damages to the equipment / furniture.
- 6. Guidance of the users must first examine the facilities whether they are in proper function and in good condition or not.
- 7. Do not take toys away from the Indoor Children Play Area.
- 8. The Toys should be returned to the original position after use.
- 9. No running in the Indoor Children Play Area.
- 10. The Staff of Club Aqua reserves the right to restrict any entry if the area is overcrowded.
- 11. All users should not bring any foods enter the Indoor Children Play Area.
- 12. Smoking, eating, drinking and littering are strictly prohibited in the Indoor Children Play Area.
- 13. No coaching is permitted in the Indoor Children Play Area unless prior approval is obtained from Club Aqua.
- 14. Club Aqua shall reserve the right to refuse admittance for any person who habitually disregards any of the aforesaid requirements and / or causes nuisance and / or danger to other users.
- 15. Club Aqua shall reserve the right to suspend the Indoor Children Play Area at any time and / or for any period of time for cleaning purpose and / or maintenance repairs without prior notice.
- 16. The management shall not be held liable for any loss of and / or damage to any personal properties and / or belongings. All users of the Indoor Children Play Area are at their sole responsibilities.
- 17. For training session and / or demonstration specially arranged by Club Aqua, the Indoor Children Play Area will be reserved for such purpose.
- 18. Club Aqua shall reserve the right to amend the above guidelines without prior notice.
- 19. This Indoor Children Play Area operates for the sole benefit of owners, tenants, users and visitors. The owner and management will not take any responsibility for the usage of all equipment and the safety of all users in this Indoor Children Play Area nor will take any responsibility for advice given by any of the instructors.
