

## 董事會所休閒區

- 1. 使用人士必須為持有碧海藍天智能咭之住戶或由持有智能咭住戶陪同之訪客。
- 2. 使用人士須出示已登記的智能咭及於接待處辦理租用手續後,才能進入及使用董事會所休閒區。
- 3. 十六歲以下人士,必須由成人陪同下方可使用董事會所休閒區。
- 4. 董事會所休閒區最多容納人數上限為30人。
- 5. 不可在董事會所休閒區內進行任何商業及金錢交易活動。
- 6. 使用人士請將使用後的器材放回原位及嚴禁隨意移動董事會所休閒區內之器材傢俬,如有損毀,須 按照市價賠償一切損失。
- 7. 董事會所休閒區範圍內嚴禁吸煙或拋棄垃圾。
- 8. 倘若任何人士經常違反上述規則或故意騷擾或危害其他使用人安全,會所有權拒絕該等人士進入會 所範圍內。
- 9. 會所有權隨時關閉董事會所休閒區,以便進行清潔、保養或維修工程,而無須事前通知。
- 10. 使用人士須自行負責本身之財物,管理公司對私人物品之損毀或被竊概不負責。
- 11. 會所為住客安排特別課程或項目期間,董事會所休閒區將不開放予其他人士使用。
- 12. 確定租用場地後,不設退款或更改場地安排。
- 13. 會所保留隨時更改以上董事會所休閒區使用規則之權利而毋須另行通知。
- 14. 董事會所休閒區只供業主、租客或授權人士使用。業主及管理公<mark>司不會對董</mark>事會所休閒區使用人士 的安全負上任何責任,敬請留意。

## **Director's Club Regulations**

- 1. All users must be a holder of registered Smart Cards of AquaMarine or a guest accompanied by a resident who can produce his or her Smart Card.
- 2. All users must present their registered Smart cards and register before they are permitted to use the Director's Club.
- 3. All users under the age of sixteen (16) should be accompanied by an adult who shall remain in attendance at all times and be fully responsible for any child in whose care.
- 4. Maximum of 30 persons are allowed to stay in the Director's Club at any one time.
- 5. Any kinds of commercial activities or activities involving money transaction are prohibited in the Director's Club.
- 6. The equipment should be returned to the original position after use and relocation of the equipment inside the Director's Club is strictly prohibited. User will be held liable and required to pay full compensation at market rate for any damages to the equipment / furniture.
- 7. Smoking and littering are strictly prohibited in the Director's Club.
- 8. Club Aqua shall reserve the right to refuse admittance for any person who habitually disregards any of the aforesaid requirements and / or causes nuisance and / or danger to other users.
- 9. Club Aqua shall reserve the right to suspend the Director's Club at any time and / or for any period of time for cleaning purpose and / or maintenance repairs without prior notice.
- 10. The management shall not be held liable for any loss of and / or damage to any personal properties and / or belongings. All users of the Director's Club are at their sole responsibilities.
- 11. For training session and / or demonstration specially arranged by Club Aqua, the Director's Club will be reserved for such purpose.
- 12. No refund or change of time is allowed after confirmed the reservation.
- 13. Club Aqua shall reserve the right to amend the above guidelines without prior notice.
- 14. This Director's Club operates for the sole benefit of owners, tenants, users and visitors. The owner and management will not take any responsibility for the usage of all equipment and the safety of all users in this Director's Club nor will take any responsibility for advice given by any of the instructors.
